

**DETERMINATION AND FINDINGS

SOLE SOURCE PROCUREMENT**

1. **Authorization<sup>i</sup>**

2. **Minimum Need:**

The Office of the People's Counsel (OPC) requests the services of Cintas Corporation #2 to provide OPC with a comprehensive suite of first aid products.

3. **Estimated Fair and Reasonable Price:**

\$ 4,000

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel (OPC) is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Cintas Corporation #2 leads the industry in supplying corporate products including, but not limited to, first aid, safety, fire protection products
- C. OPC has utilized Cintas Corporation #2 to provide onsite first aid products for numerous years, including fiscal year 2019, and has an immediate need to restock its Cintas first aid kits.
- D. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Cintas Corporation #2.
