

**DETERMINATION AND FINDINGS
FOR
SOLE SOURCE PROCUREMENT**

1. **Authorizationⁱ**

- DC Law: 34-801
- 15 DCMR: §3700

2. **Minimum Need:**

The Office of the People's Counsel (OPC) requests the services of Radio One (Urban One, Inc.) to provide a package of eighteen, one second traffic radio spots for broadcast of OPC consumer service announcements on stations WPRS-FM and WMMJ-FM.

3. **Estimated Fair and Reasonable Price:**

\$ 3,506

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. OPC requests the services of Radio One (Urban One, Inc.), is a multimedia company that serves the Washington, D.C. metro area.
- C. WTOP Radio One (Urban One, Inc.) had exclusive rights to broadcast on WPRS-FM and WMMJ-FM radio networks.
- D. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Radio One (Urban One, Inc.).

ⁱ Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Service Date Chang, and Public Service Commission Independent Procurement authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, hereby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
